The first sweet fruit of labour came in the form of first compulsory license in India. India's first case of granting compulsory license was granted by the Patent office in 2012 to an Indian Company called Natco Pharma for the generic production of Bayer Corporation's Nexavar. The Government took this decision for the general public benefit as the medicine was used in treating liver and kidney cancer. However, it was heavily criticized by the Pharmaceutical Companies, and Rajeshwari & Associates took up the case and represented Indian companies in this Novartis V/s Union of India case. The firm strategized it right from the beginning till the end and argued the matter in-house to win at all for a right from the Patent office to Supreme Court. The verdict is not only just the first ever compulsory license, but the first ever that was adjudicated by a court of law. It is first granted in India and is the first-of-its-kind for liver cancer. The grant of compulsory license has been historic as it has helped to save the lives of millions of people affected by liver and kidney cancer.

This was just the beginning of achievements and subsequent cases have kept the firm going. Since then,

Generic Challenges

to change in the way people look at Intellectual property. There's also competition from non-traditional legal service providers such as KPOs businesses entering the market. Though their competency in court-room cannot be matched with traditional lawyers, yet it is an issue to contend with. Lastly with the economic downturn and other factors, law firms are required to cut costs but the kind and type service remain the same; however, the billing models change leading to some impact which affects the overall picture.

Pending Cases

One of the main reasons for pendency in the judiciary is a large number of cases that are already pending in courts. The judiciary is alive to the problem and is taking steps in the form of evening courts, less vacation, fewer adjournments, technology etc. The need of the hour is getting more judges on-board so that matters can be adjudicated and disposed-off quickly. A further step may be to fix a timeline whereby each stage of the case is fixed—without a possibility of extension of time and a definite time period within which case must necessarily be disposed-off. Lawyers also have a role in reducing the pendency by preparing well and ably assisting the court when the matter is taken up, rather than seeking adjournments.

The gap between Law Formulation and Law Enforcement In the legal system, laws are made with the intervention of the Parliament – but at the time of enforcement, there are issues. These can be solved, sometimes through interpretation and at times through amendment of the law.

We need both – quick amendments to the laws so that the lawmakers can catch up with the developments and plug the apparent loopholes; also full co-operation of both lawyers and judges. As citizens and as officers of the court, lawyers have a duty not just to the client that we represent but also to the system and the society at large; something that we must never lose sight of.

Teaching the Young

Rajeshwari advises the young generation to focus on legal matters from the beginning. She says, "Startups often tend to believe that legal can be taken care of when there is a problem. However, in real life, we see that it is too late by then. Both single entrepreneurs and startups should look at all the legal issues before launching their business. Many confuse the consultations with a CA as 'legal advice'-however, that is not the case and if at all, it is limited help. They need more, especially with a focus on intellectual property."

Future Perspective

The firm is planning to expand to other areas of law as well as other cities to reach out to larger mass and assist them with intellectual property matters in the near future. There is a huge pool of home-grown enterprises and businesses that have come up in the last few years and who are developing innovative products but are functioning without IP protection. The intellectual property today is a need, not a luxury; and the firm wants to spread this message across India.
